- 1. Please read these terms and conditions carefully. By entering into this Check Point Arsenal Visit Sales Competition ("Promotion"), you agree that you have read these terms and that you agree to them. Failure to comply with these terms and conditions may result in your disqualification from the Promotion.
- 2. This Promotion is run by Westcon-Comstor and Check Point Software Technologies Ltd. ("Promoter").
- 3. To enter this Promotion you must be: (a) a registered partner of Westcon and Check Point, (b) a tier 2, 3, 4 or NIP partner, (c) and a resident of Australia.
